Message from Sherry

This is FPSC's fourth year of "Bringing Families Home!" Two of our moms spoke at our recent Celebration of Gratitude about what Family Promise means to them and expressed their thanks for all the support and love they received from all the volunteers. One mom talked about how scared she was when she found out that she and her daughter would be moving from church to church each week and meeting new people frequently.

FPSC works like this: Sunday afternoon parents get bedding together and pack items the children will need during the week. The van driver picks them up at 5 pm on Sunday so they can arrive early at the host site to get their beds set up before eating dinner. They often wake up by 6 am to be ready to leave the host site between 6:45 and 7 am. School age children catch the bus at 7:20 am and return about 3:40 pm. Parents head to work or stay at the Family Center during the day to do housing and job searches. Often parents have appointments and will walk if close by or FPSC staff will transport them. By 5:30 pm, they are headed back to the host site for a meal, activities and sleep. On Sunday morning, families pack up all their items, the beds are loaded in the van, and they are off to the Family Center before church starts.

Our families have to balance many schedules - school, work, appointments, case management, housing and job searches and host site schedules. They have to take everything they might need during the night to the host site because returning to the Family Center in the evening is not an option. Families are amazing "adjusters" - they are resilient and want to be independent again. The mom who talked about being scared when she entered the program ended by saying she quickly found out that she had no reason to be scared. She stated: "All the people we met just loved me and my daughter so much. No one judged me and everyone just accepted me as I was and showed me someone cared about us." Thanks for all you do! Hope to see you at the Steak Dinner & Silent Auction later this month.

Volunteer of the Month Lesley Bowyer



Family Promise has been so fortunate to work with Lesley Bowyer! This talented pastor's wife manages a full time job and volunteers her time for the important job of keeping the books for Family Promise! While initially the time required in setting up the books was intensive, Lesley allows that now that things are running smoothly. She spends about six to seven hours a week on the books and payroll.

Involved with FPSC from its inception, she and her husband, Mark, volunteered with Family Promise of Allen County, Ohio, through the Pleasant View Church of the Brethren. In fact, Pastor Mark was the one who suggested the organization to George Bowers and other ministers during a clergy Bible study as they discussed ways to help the homeless in our county. Lesley is also a co-coordinator with Libby Rocco at host church Wakemans Grove Church of the Brethren.

Lesley had quite the exotic upbringing! Born in England, she grew up on a series of boats in England and the Mediterranean. She

attended school in New Zealand for several years and ended up in the Caribbean living on her own sailboat until a hurricane devastated the area and her boat was wrecked. Time to move the family to Ohio!

"Homelessness is an issue that is dear to my heart - taking care of our FPSC families is a true mission," Lesley said. She also commented, "Everything is going swimmingly- our community really responded well!"

Day Care Desert Soon to Have Oasis

As we noted in our December 2018 newsletter, there is **very little childcare available in Shenandoah County - much less affordable childcare.** FPSC has encountered this situation many times as we see how lack of childcare plays into homelessness and the ability to get and maintain a job.

Yvonne Frazier, executive director of Healthy Families, has found the same dilemma as she works with young families in Shenandoah and Page Counties. Healthy Families offers in-home services to families with children under the age of 5 (when they enter Head Start or preschool). The nonprofit assists parents in overcoming barriers so that they can become the best parents and people. In this process, parents have been able to find jobs but no childcare (or no childcare that fits in their budget). This is a big hurdle for them to overcome in continuing to improve their lives and family situations. Yvonne says she has seen this same concern over and over again in her 35 years of social service work in the area.

Yvonne put together a group of concerned community members to look at the needs and opportunities. FPSC director, Sherry Arey, has participated in the process as well as many others. Out of these brainstorming sessions and the enthusiasm of Yvonne Frazier and others, the beginning of a solution has evolved: **Community Care and Learning Center**. The mission is: **To provide accessible, quality child care that supports parents' ability to maintain stable employment knowing their children are in a safe, nurturing, and enriching environment.** New Market is one of the towns in Shenandoah County with no full-day childcare center. New Market draws employees from both Shenandoah and Page Counties. With this in mind, this group set out to find a place – they found one (the previous site of an antique shop) at 189 E. Lee Highway near Pack's Frozen Custard stand. But that was just the beginning of the process!

The group is currently applying for 501(c)(3) nonprofit status with the Internal Revenue Service. They have navigated their way through building code restrictions for childcare facilities as well as Health Department regulations and the Virginia Department of Social Services licensing process. An engineer has drawn up functional use plans for the 1,300 square foot space, and the landlord is assisting in making the necessary renovations. It has been a real balancing act to get all of this organized, and it has come with a price tag including licensing fees, liability insurance, renovations, etc. The goal at the moment is to gain support and donations to cover start-up expenses to open the doors, when fees and tuitions will cover the majority of operational costs.

The plan is to begin providing care at the end of the 2018-2019 school year. CCLC will provide childcare from 6 am to 6 pm, Monday through Friday and will accept children from the age of 2-1/2 to 12 years. As a nonprofit, they will offer sliding-scale tuition based on the family's ability to pay, and scholarships will be available. The group needs community involvement in the form of donations and work teams in order to make this dream a reality — **Children are our Future!**

The board of directors (Yvonne Frazier, Peter Hughes, Teresa Taylor, Pam Uhl, Debbie Davis, Tim LaPierre, and Tony Cooper) welcome your interest, support and donations. Community Care and Learning Center has a GoFundMe.com account where you can donate online, or contact them at cclcenter.nm@gmail.com. The group sees this opportunity as a great start and envisions their services could expand to provide childcare for second shift workers and believes this could be a model for opening other childcare centers. Keep your eyes open for their new website which should be posted soon, thanks to students from James Madison University who are developing the site.

Case Manager's Corner

This month I write about a subject that is close to my heart – single mothers. According to coabode.org there are almost 11 million single mothers raising over 20 million children by themselves. In the United States most single mothers are separated, divorced or widowed; they work more hours but have a higher poverty rate than other high-income countries. "Single-parent families are among the poorest in the nation and as such, are extremely vulnerable to homelessness. Among all homeless families nationwide, over three quarters were headed by single women with children." The single parent household typically comprises a mother in her late 20's with 2 children.

Family Promise National states the three top reasons for family homelessness are lack of affordable housing, unemployment and poverty. As a case manager with Family Promise of Shenandoah County, I work with these single mothers (as well as other parents of our guest families) to find housing, jobs, child care and other assistance through local agencies and other nonprofits. Some of the organizations we work with are the Dept. of Social Services, Shenandoah County Schools, Dept.of Health Women's Infant Children program (WIC), Shenandoah County Pregnancy Center, Catholic Outreach, Shenandoah Alliance for Shelter and A Small Hand. For many of our single parents, achieving these goals can be difficult and may keep them in in the program longer than a two-parent household.

Most of the single parent guests in FPSC do not have the necessary support from family members. Many have burned the bridges within their family support systems for a variety of reasons and are alone when it comes to parenting their children. Coming into a homeless shelter like FPSC is difficult in itself, and trying to establish any type of routine can be difficult. The staff provides support by offering parenting skills, 'motherly' advice and tough-love when necessary. Sometimes we actually refer to ourselves as "The Aunties"!

Once a family graduates from the program, we try to stay connected with the family, allowing them to return to the center to do laundry and obtain additional toiletries or household items. We can continue case management assistance if needed. For many of our families, whether single or two parent households, knowing they have this extra "family support" can mean the world to them. Thank you for being a part of what we do at FPSC.

Did You Know?

In the first three years, FPSC has:

- ➤ Sheltered 44 families (153 individuals, 93 children, 53 under age five)
- Provided 7,644 nights of safe shelter (estimated at \$50 per room per family) valued at \$102,550
- ➤ Had almost 700 volunteers provide over 50,000 volunteer hours; at minimum wage of \$7.25/hour, valued at \$362,000!
- ➤ Hosted veterans, pregnant moms, singleparent families headed by moms, singleparent families headed by dads, single-parent families headed by a grandmother, as well as two-parent families
- Opened the Family Center
- Transported families in a donated van
- Supported families through Case Management
- ➤ Offered one apartment for transitional housing; another coming soon.
- ➤ Has had no government funding from federal, state or local levels
- Participated in community discussions regarding childcare, public transportation, and affordable housing
- ➤ Networked with inviduals, churches, businesses, nonprofit & civic organizations
